





WATER SUPPLY

Domestic Cold and Hot mains supply is required via separate 1/2" BSP (15mm) stop-taps with male threads. These should be pre-installed in an easily accessible position. Water supply must be microbiologically safe to drink, with a minimum dynamic water pressure of 250kPa and a maximum of 1000kPa.

POWER SUPPLY

A standard 10 amp power outlet plus an additional standard 10 amp outlet are required. Both outlets located no further than 1000mm from the underbench unit. The system is supplied with a 1 metre flex cord and plug.

FILTRATION

Billi's range of premium filters utilise BWT's unique Fibron X technology. Billi's filter range provides superior taste, water quality, consistent filter life and peace of mind when it comes to hygiene.

Filter supplied: 994051 (5 micron). Replacement filters available: 994052 (0.2 micron), 994054 (HSD option), 994056 (Sediment only) and 994060 (0.2 micron Sediment Only).

CO2 Cylinder

The CO2 gas cylinder supplied must be secured in a suitable location. Each cylinder contains 1100g of CO2 and should be installed in a well ventilated area.
